COMMUNITY INITIATIVES AND EVALUATION

The work of REACH is always evolving, as communities, partners and various levels of government connect with the organization to create strategies to address emerging challenges. REACH assesses whether to become involved in new collaborative opportunities based on the following criteria:

- **Impact on community safety**
- **Alignment with REACH focus areas**
- **REACH's capacity to support**
- **Fulfills a need in the community, not duplication**
- **Geographic scope**
- **Input from community partners and other stakeholders, including community members the initiative aims to support**

In 2024, REACH Edmonton rolled out a new process for measuring the organization's impact. As the work of REACH has grown, a bird's eye view has become essential to clearly reflect its impact. Community initiatives are organized according to eight focus areas. REACH believes that prioritizing these areas will have the biggest impact on community safety and well-being. Extensive work has been done to create the new evaluation framework for community initiatives, guided by the Community and Urban Safety and Monitoring project, which includes Edmonton as one of 10 pilot sites, led by the Canadian Centre for Safer Communities. The project provides an initial framework with key indicators and measures for the monitoring of community and urban safety. The UN-Habitat, the European Forum on Urban Security (EFUS), and other partners co-developed the Urban Safety Monitor (USM) prototype in 2021.

REACH has developed key performance indicators for each focus area to ensure measurable and meaningful reporting, and will work towards collecting these indicators in 2025. Results will be communicated in the 2025 Business Plan Report Back.
